YOUR ROLE AND RESPONSIBILITIES

We are looking for a Youth Representative to bring their lived experience to support Lambeth Council assess Somerleyton Road bidders responses to the Social Value requirements and the Engagement requirements.

- To attend training to participate in the assessment panels for Development partner looking to take on the Somerleyton Road project
- Following training provide insight on the bidders responses to the Social Value requirements and the Engagement requirements
- Following training adhere to procurement rules when marking bidders response to Social Value requirements and the Engagement requirements

- Attend a 2 hour training session week beginning 17th November

- Review updated bids and provide suggested scores on social value and engagement – 4 hours
- Attend a 1 hour Social Value Evaluation Panel in March/April 2024
- Attend a 1 hour Engagement Evaluation Panel in March/April 2024

PROJECT BACKGROUND

Lambeth Council has plans to build more than 320 new homes in Brixton as the second phase of a scheme that has already delivered one of London's newest theatre spaces and affordable workspace for local businesses.

The Somerleyton Road scheme will deliver new social rent homes for local families on the waiting list, a new extra-care facility for residents with social care and support needs and a new community space to replace the existing provision.

The council's objective is to deliver much-needed affordable housing on the site, and through the development ensure that the investment will deliver wider social and economic benefits to the local community. The objectives for the site include:

- High quality new homes and affordable housing
- Next generation extra care facility
- Net zero - A resilient and sustainable development
- Social value benefits, including an employment & skills programme
- Safer and healthier streets and spaces
